Emergency crews were prompt and professional

Editor,

On Dec.21, extreme weather conditions, including icy roads, blowing snow and poor visibility contributed to a massive traffic crash. In all, as any as 100 vehicles were involved, either damaged or having slid off into the snow-covered median and shoulder. I was assigned the crash investigation and coordination of emergency services.

As a veteran Michigan State trooper I have investigated many traffic crashes involving multiple

vehicles, but never anything to this extent.

Officer Schadler, of the Lincoln Township Police Department, was first on scene. Officer Knapp of the St. Joseph Township Police Department, and I responded to assist. Immediately, we were overwhelmed as one vehicle after another, including jack-knifed semi tractor-trailers, crashed into each other before I-94 was shut down entirely. Lt. Lang (St. Joseph Township) Trooper Cook, (state police, Bridgman) and other officers arrived. The first priority was searching through the wreckage to locate and remove the injured. Unfortunately, among them there was one fatality.

First Lt. Willie Mays, (state police, Bridgman) was notified and coordinated support from fellow Bridgman Post personnel (many came from home), and more troopers came from the Niles, Paw Paw and South Haven posts.

Berrien County Sheriff Paul Bailey arrived at the scene and offered assistance. Lt. Goulooze, accident investigator, was contacted and requested to handle the fatal traffic crash.

The St. Joseph Township Fire Department and Medic 1 ambulance crews removed and treated the injured. They also transported motorists involved to the nearby Lake Breeze Hotel.

Jeff's Towing, Hasse's Towing and other wrecker services were very professional. In only a few hours, the damaged passenger vehicles, semi tractor-trailers and debris were cleared and I-94 was reopened.

Although closed for business, the Lake Breeze Hotel was accommodating. Red Cross volunteers established a base of operations there and helped those displaced, including families with small children. I was especially thankful for the hot coffee! Dep. Moore (Berrien County Sheriff's Department) and Officer Neal (Benton Township) assisted by transporting local families home or to a nearby relative.

Berrien County dispatch and the state police regional dispatch efficiently coordinated all of these services.

The motorists involved were extremely patient and repeatedly expressed their gratitude for all our efforts.

I wish to express my sincere appreciation to everyone involved. I am proud to have been part of this cooperative and coordinated effort, which is exactly what the public expects from emergency services.
